



Water Rebate Program Residential Rain Barrel Application

Program Eligibility and Guidelines

- Eligibility is limited to residential homes only; commercial buildings are not eligible.
- Applicant must currently reside at or own the home and have a City of League City water utility account in good financial standing for the property where the rain barrel(s) are installed.
- Completed applications must be received by the City of League City within **30 days of purchase** date. Rebates will be processed in the order they are received on a first-come, first-served basis. Incomplete applications will not be processed. Rebates are subject to the availability of funds – For this sale, funds are available for 120 rebates.
- Rain barrel(s) **MUST** be installed and be functional at the property before applying for the rebate. A site inspection may be conducted to verify installation and functionality.
- The City of League City reserves the right to terminate or modify the rain barrel rebate program at any time.

Process

- The City of League City will issue a \$25 water utility credit for up to two rain barrel installations per household per calendar year.
- Resident must provide proof of purchase.
- Completed applications must be received by the City of League City within **30 days of purchase** date. Rebates will be processed in the order they are received on a first-come, first-served basis. Incomplete applications will not be processed. Rebates are subject to the availability of funds – For this sale, funds are available for 120 rebates.
- Applications take 30 days to process.

Rebate Program Terms

By signing below, I confirm that I have read and understood the program guidelines, and agree to the following:

- I am a City of League City single-family residential water customer with an account in good standing.
- The rain barrel is installed at the address above and will remain at this address for a minimum of two years or for the lifetime of the product.
- The rain water will be used for non-potable, outdoor uses only.
- The rain barrel must stay securely covered and screened to restrict access by children, pets, rodents, and insects.
- Prior to issuance of a rebate, a site inspection may be conducted to verify installation. The rain barrel must be installed and functional at the time of the inspection.
- Rebates are offered on a first-come, first-served basis, and are subject to availability of funds.
- Processing of completed applications takes approximately 30 days. Once processing is complete and the rebate is approved, a credit will appear on my utility bill.
- I have included all of the required documentation to apply for this rebate.
