
The privilege of speaking at this time is limited to the following persons: residents, persons having an ownership interest in property or a business located within the City, or their attorneys.

If addressing a specific agenda item, speakers must keep their remarks specific to the item being considered by the Board. Any speaker making personal attacks or using vulgar or profane language shall forfeit his/her remaining time and shall be seated.
