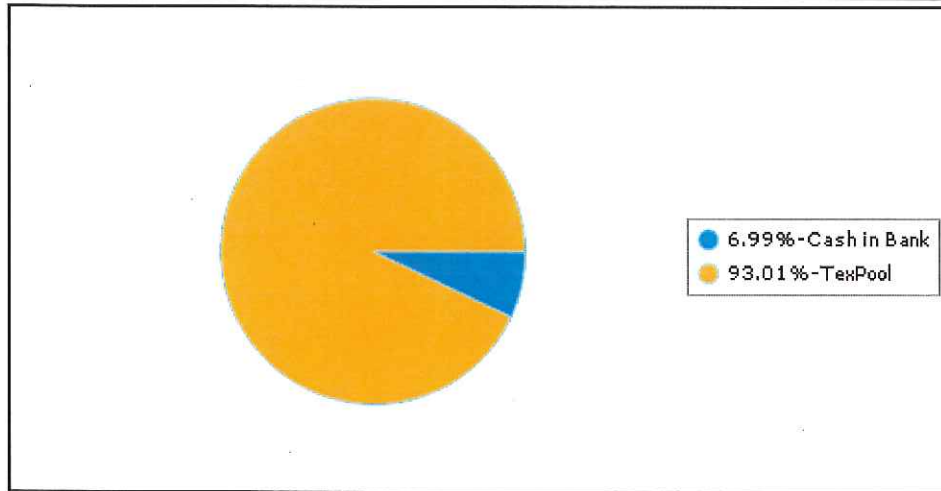

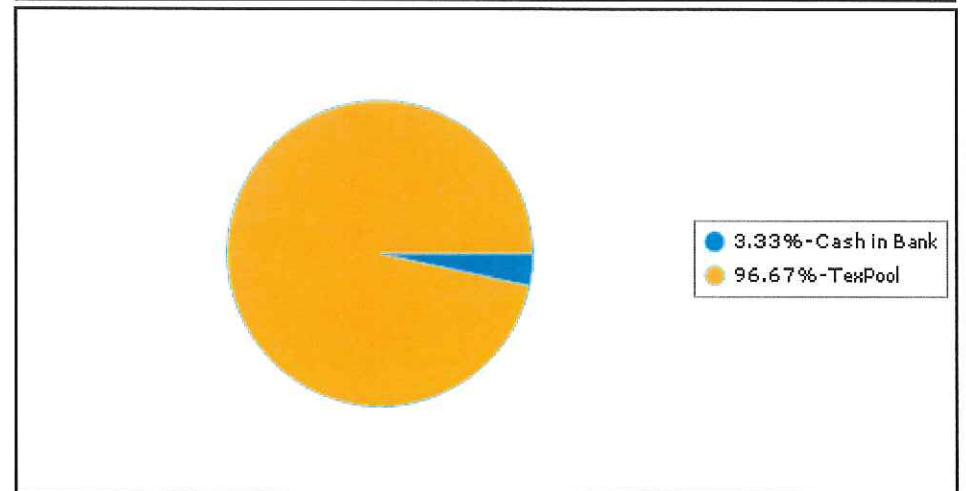

Portfolio Holdings as of 6/30/2018





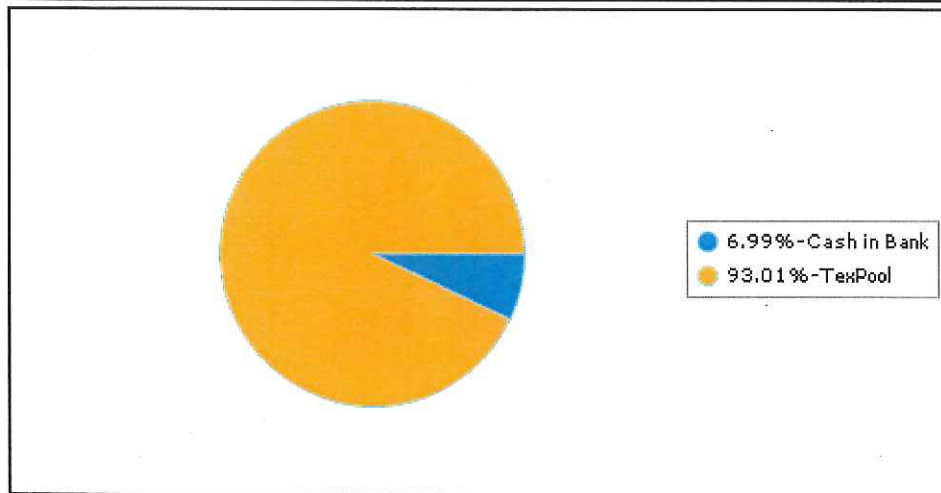
